Tuition is an annual fee and based on a ten-month academic calendar. School breaks, teacher planning days, and holidays are included in the tuition rates. Tuition is NOT prorated for breaks, planning days, holidays, sick days or vacations. ALL TUITION AND FEES ARE NONREFUNDABLE. BHPS Pre-K 4 (Non-VPK) Full Day tuition is \$7,250 per year.

For your convenience, choose one of the following payment plans available:

- Annual: 1 installment of \$7,150 due August 1st of the academic year (\$100 discount).
- Semi-Annual: 2 installments of \$3625 due the 1st of August and the 1st of January.
- 10 Payment: 10 installments of \$725 due the 1st of each month, August through May.
- 20 Payment: 20 installments of \$367.50 due the 1st and 15th of each month, August through May.

Other Fees (non-refundable):

1. There is a \$150 enrollment fee due at the time of enrollment for new students.
2. There is a \$100 registration fee for returning students.
3. The Academic and Program Fee of \$250 is due September 30th, or in two installments (Sept. 30th & Jan. 31st).
4. Tuition is due on the first of each month. There is a \$25 late fee for any payments received after the 5th of the month.
5. All financial accounts must be kept current. Delinquent accounts may result in student dismissal from school if not resolved. Parents will be responsible for returned check bank fees and any necessary legal fees incurred in the process of collecting past due balances. The current fee for returned checks is \$30.

Full Day Student Late Pick up Policy:

Tuition is NOT prorated for breaks, planning days, holidays, sick days or vacations. ALL TUITION AND FEES ARE NONREFUNDABLE. Qualifying Pre-K 4 students receive state funding from the Florida Department of Education in conjunction with the VPK program, applicable toward partial tuition. In addition, BHPS VPK 4 Full Morning Parental Responsibility of tuition is \$3,000 annually. (New enrollees from other VPK programs will be responsible for all fees due if VPK funds are not available.)

For your convenience, choose one of the following payment plans available:

- Annual: 1 installment of \$2,900 due August 1st of the academic year (includes \$100 discount).
- Semi-Annual: 2 installments of \$1500 due the 1st of August and the 1st of January.
- 10 Payment: 10 installments of \$300 due the 1st of each month, August through May.
- 20 Payment: 20 installments of \$152.50 due the 1st and 15th of each month, August through May. (This includes a \$5.00 per payment processing fee.)
