**(August through May, ten-month academic calendar)**

**Tuition is an annual fee and based on a ten-month academic calendar. School breaks, teacher planning days, and holidays are included in the tuition rates. Tuition is NOT prorated for breaks, planning days, holidays, sick days or vacations. ALL TUITION AND FEES ARE NONREFUNDABLE. Qualifying Pre-K 4 students receive state funding from the Florida Department of Education in conjunction with the VPK program, applicable toward partial tuition. In addition, BHPS VPK 4 Academic Day Parental Responsibility of tuition is \$4750 annually.**

*(New enrollees from other VPK programs will be responsible for all fees due if VPK funds are not available.)*

For your convenience, choose one of the following payment plans available:

- Annual: 1 installment of \$4650, due August 1<sup>st</sup> of the academic year (includes \$100 discount).
- Semi-Annual: 2 installments of \$2375 due the 1<sup>st</sup> of August and the 1<sup>st</sup> of January.
- 10 Payment: 10 installments of \$475 due the 1<sup>st</sup> of each month, August through May.

**Other Fees (non-refundable):**

1. There is a \$100 enrollment fee due at the time of enrollment for new students.
2. There is a \$75 registration fee for returning students.
3. The Academic and Program Fee of \$100 is due on September 30<sup>th</sup>, or in two installments (Sept. 30<sup>th</sup> & Jan. 31<sup>st</sup>).
4. Class Party fee of \$25 due October 15<sup>th</sup>.
5. Tuition is due on the first of each month. There is a \$25 late fee for any payments received after the 10<sup>th</sup> of the month.
6. All financial accounts must be kept current. Delinquent accounts may result in student dismissal from school if not resolved. Parents will be responsible for returned check bank fees and any necessary legal fees incurred in the process of collecting past due balances.
7. School Readiness payments must be made by the 15<sup>th</sup> of each month. Delinquent accounts may result in student dismissal and loss of School Readiness funding.

**Early Morning Care** (7:00 a.m.-8:45 a.m.) is an additional cost of **\$50** per month.

**After School Care** (3:00p.m.-6:00p.m.) is an additional cost of **\$100** per month.

**For both Early Morning and After School**, the discounted cost is: **\$140** per month.

*\*Please note that our afterschool program ends at 6 p.m. The fee for late pick up (after 6pm) will be assessed at the following rate: \$15 up to the first 15 minutes after 6 pm, and \$1 per minute thereafter.*
